Application Terms:

The applicant can opt to end membership within the first 90 days of the probationary membership, with excess dues being returned on a pro-rated basis. No dues or fees will be returned if the applicant ends membership after the first 90 days of the probationary membership.

Safety Code and Rules:

I understand that the hobby of flying models may present hazards to participants, spectators, fellow aeromodelers, and others.
